#### The new initiative aims to:

#### **About PCORI**



- An independent research institute authorized by Congress in 2010 and reauthorized in 2019
- Governed by a 21-member Board Governors representing the entire healthcare community
- Funds comparative clinical effectiveness research (CER) that engages patients and other stakeholders throughout the research process

#### **PCORI's Mandate**



• "The purpose of the Institute is to assist patients, clinicians, purchasers, and policy-makers in making informed health decisions by advancing the quality and relevance of evidence...through research and evidence synthesis...

... and the dissemination of research findings with respect to the relative health outcomes, clinical effectiveness, and appropriateness of the medical treatments, services..."

— from PCORI's authorizing legislation

### **Research Done Differently**




- Our research seeks answers to real-world questions about what works best for patients based on their circumstances and concerns — which traditional healthcare research has often left unanswered
- We engage patients, caregivers, clinicians, insurers, employers, and other stakeholders throughout the research process
- We aim to produce evidence that can be easily applied in real-world settings

...to make it more likely that we'll get the research questions right and that the study results will be useful and taken up in practice.

# The Science of Engagement



- The systematic study of methods for and outcomes of engagement to inform high-quality, patient-centered research
- Intended to help inform engagement practice, guidance, and resources to achieve meaningful engagement and inclusion of diverse and representative partners

### PCORI's Engagement Evidence To Date



- Engagement is feasible in all phases of CER and PCOR and with a variety of stakeholders
- Engagement can influence the design and conduct of research studies in meaningful ways including acceptability, feasibility, quality, and relevance
- Engagement can benefit the patient and stakeholder partners, communities, and researchers involved
- There are known challenges to address, including those related to infrastructure and resources, people and teams, organizational policies, and balancing views and priorities

# SoE Potential Topic Areas for Study



What defines successful engagement, and for whom?

How can engagement be measured? What indicates that a study is patient-centered?

What are the approaches that support and achieve successful engagement?

Which approaches should be combined to achieve engagement aims?

Under which conditions do approaches work best and how should they be modified and resourced for different contexts, settings, and communities?

# **Key Characteristics of the Engagement Evidence Needed**



- Actionable results about how to effectively do engagement
- Generalizable or transferable knowledge
- Variety of robust designs and methods (experimental, including quasiexperimental; observational, including natural experiments; well-designed comparative case studies, etc.)
- Studies potentially including:
  - Assessment of existing engagement methods
  - Development and testing of new engagement methods
  - Development and validation of engagement process and outcome measures

# Potential Complementary & Interrelated Research Program Approaches



#### Stand-Alone Research Awards

- Study engagement across a wide set of research-related activities
- Develop and test new and existing approaches
- Develop and validate processes and outcome measures of engagement



# Studies Within a Study

- Capitalize on realworld settings
- Generate knowledge to improve CER projects and contribute to the field of engagement research
- Enhance the relevance and applicability of the evidence about engagement

# **Ideal Evidence Base on Engagement**

- Actionable approaches for effectively engaging diverse patients & stakeholders
- Information most useful for research teams implementing effective engagement
- Variety of methods and approaches


Includes request for input on questions including:
